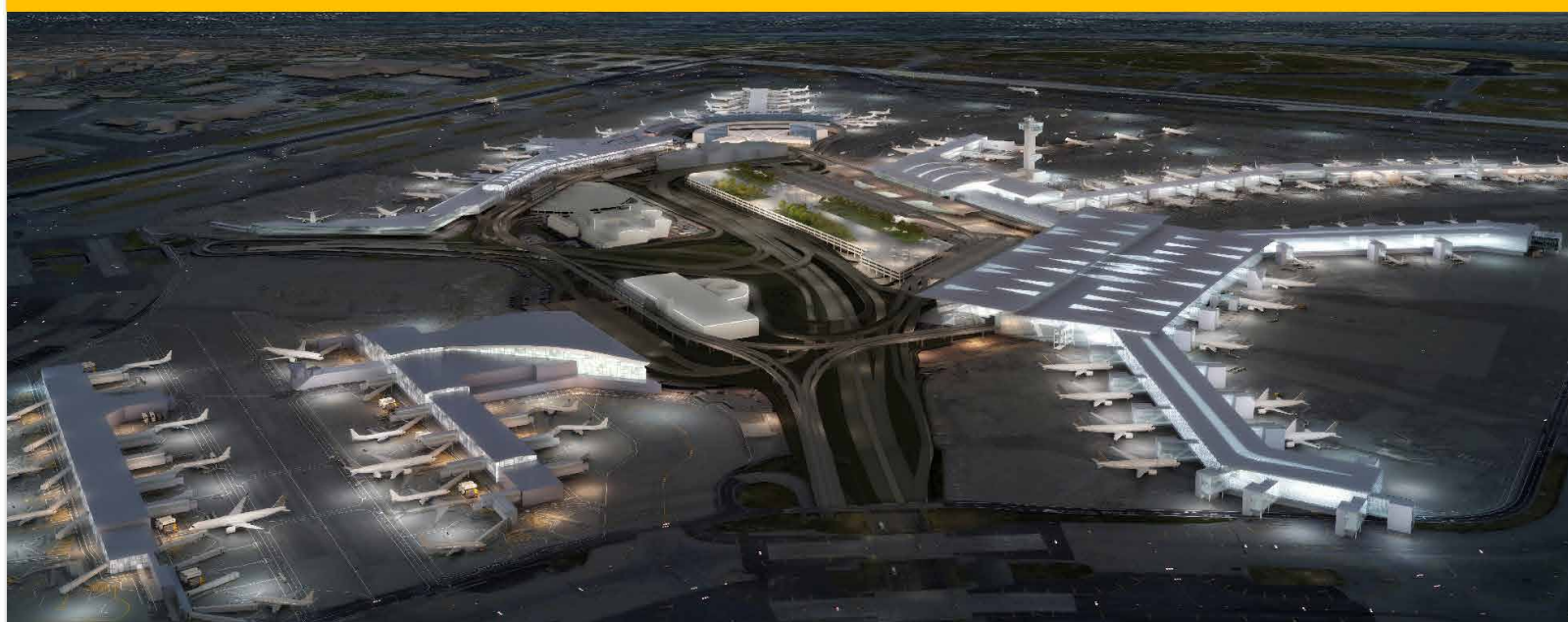

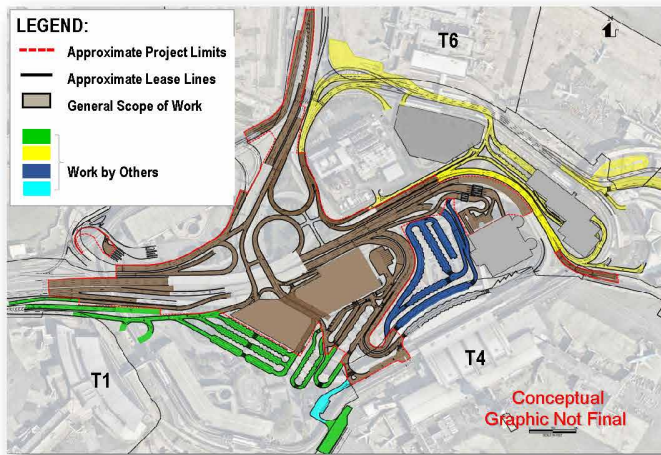

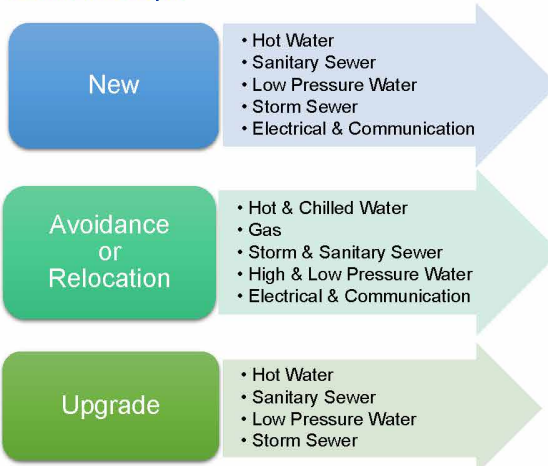

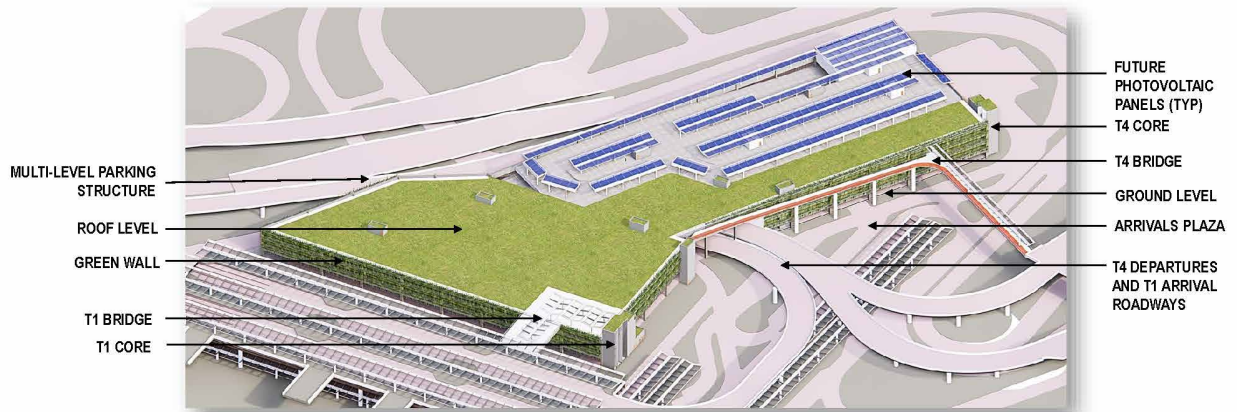

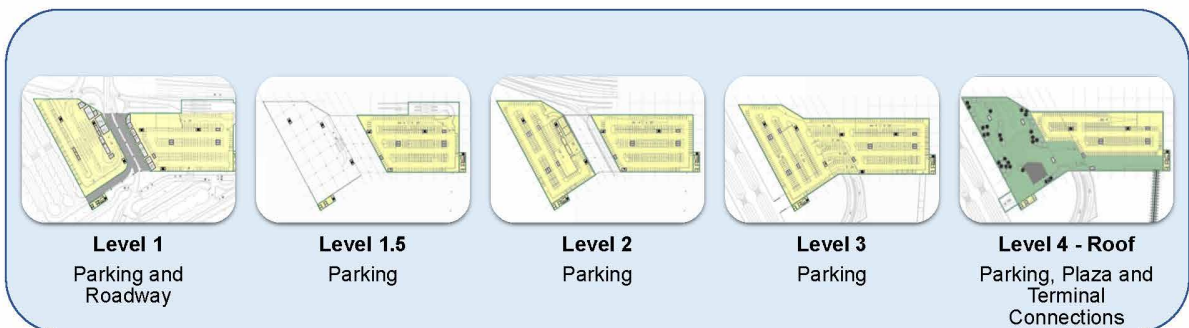

Environmental Stewardship Committee Meeting Highlights:

In November 2021, the PANYNJ Board adopted 2 new policies a net zero greenhouse gas emissions by 2050 and cutting direct greenhouse gas emissions in half by 2030. The net zero program includes: electric vehicle charging (10 chargers currently active in cell phone lot as of 2020), a redevelopment requirement of electric vehicle charging for all employees and public parking lots, electric ground support equipment & vehicles at all 3 major NY/NJ airports, which includes designating charging stations outside of the terminals for vehicles, improve recycling in terminals with more clear signage, optimize recycling/waste containment and addition of organic waste recycling. PANYNJ is the first US Transportation agency to set a net zero emissions goal. The Clean Dozen 2.0 will deploy 20+ more electric shuttle buses (36 currently in service), achieve 100% Electric PANYNJ Light Fleet by 2030, adopt airport policy for zero emissions ground support, adopt port policy for zero emissions cargo handling equipment, implement airport fast charging hub for taxis and for hire vehicles and developing a “Getting to Zero” electrification strategy by issuing a RFI. Additional goals include renewal energy ambitions, sustainable building energy efficiency, and indirect initiatives and partnerships. “We will be mean, green & lean at JFK.”



Community Development Program

Goals and Objectives

- Ensure that the Airport **remains a good neighbor to the Community** throughout the duration of the program and the Community is left in a better state than it was prior to the commencement of the Program.
- **Minimize negative impacts** caused by short-term construction and long-term airport operations on neighboring communities and **strengthen economic ties** between Airport and Community.
- **Identify and prepare MWBEs, LBEs, or ACDBEs** to compete for contracting opportunities on the Program or at the Airport.
- **Create educational programs for K-12 students** in the surrounding communities in aviation-focused STEM fields.
- **Encourage career paths in aviation** by supporting educational and vocational pathways for local high school and college students.
- **Facilitate employment of local residents**, including those with prior involvement with the justice system, on the Program and at the Airport, and create true pathways to union careers for local residents.

October 2019 Announcement

Job recruiting program that will seek to match local job seekers with positions in both airport construction and airport operations. To ensure that employment opportunities related to the JFK Redevelopment are accessible, this community development initiative will enhance outreach to underserved neighborhoods in Southeast Queens, the Rockaways, and surrounding communities. A new Rockaway Career Center in partnership with the Rockaway Development and Revitalization Corporation (RDRC) will open by Spring 2020 and will have dedicated staff members focused on connecting local residents to airport employment opportunities. The JFK Redevelopment Program partners have committed \$3 million to fund this recruiting effort.

Office for Second-Chance Employment

October 2019 Announcement

Among the top workforce priorities for the Advisory Council is ensuring employment opportunities for formerly incarcerated individuals and others with past involvement in the criminal justice system. The Second Chance Employment initiative responds to that priority by opening a new Office for Second Chance Employment (OSCE) to link major airport employers associated with local organizations with experience in the area including The Fortune Society, Thomas White Jr. Foundation, 100 Suits, Exodus Transitional Services, and Life Camp.

To maximize the chances for successful employment matches, the effort will focus on "landside" employment at NY airports (i.e., jobs not requiring access to the post-TSA checkpoint areas of the airport) and, where appropriate, non-aviation employment opportunities.

In addition, the Port Authority will host a training seminar for its contractors with the Criminal Justice Employment Initiative at Cornell University. Participating companies will learn about the benefits of hiring from the "second chance" population, including financial incentives available to them, and how to expand understanding of how to work with this population throughout their organizations.

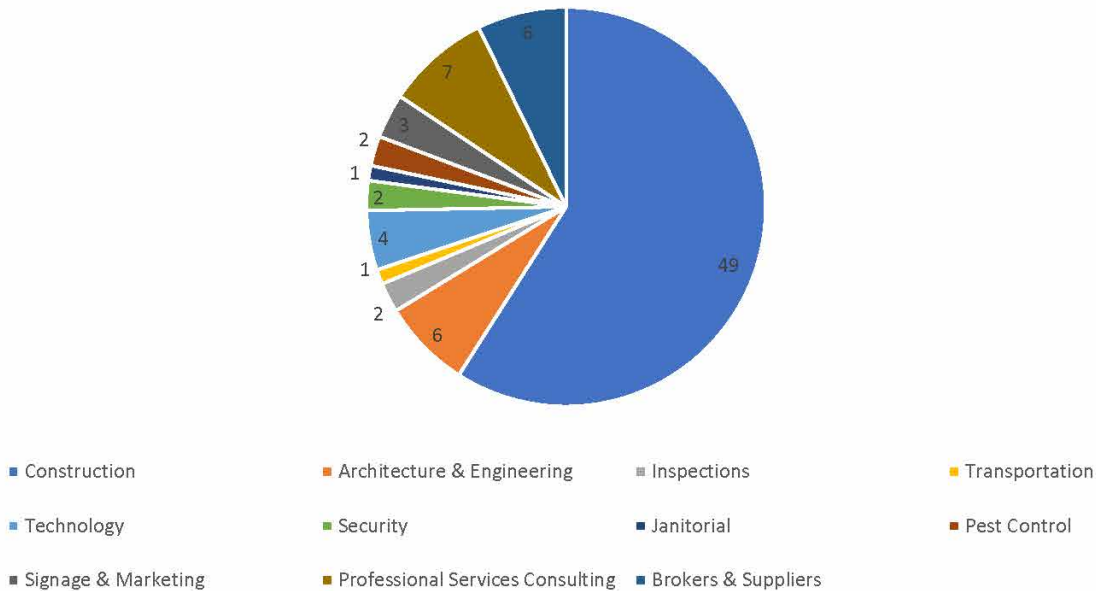

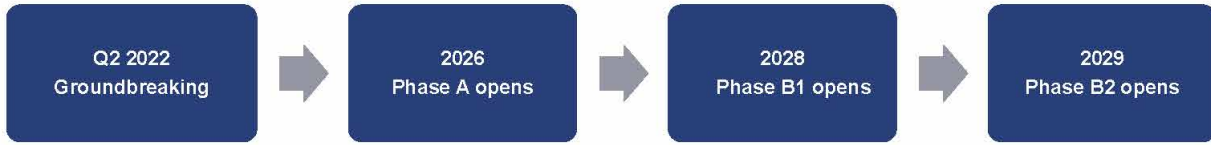
Project Update

- In December, Governor Hochul, Congressman Meeks and Borough President Richards announced that the Port Authority and The New Terminal One (NTO) had reached a revised agreement on key lease terms
- In February, Ferrovial announced that, through its Airports division, it had reached an exclusive agreement to negotiate the transfer to Ferrovial of a portion of Carlyle's stake in NTO and join current financial sponsors JLC Infrastructure, Ullico and Carlyle
- The 2.4 million square foot project aspires to be among the top-rated airport terminals in the world

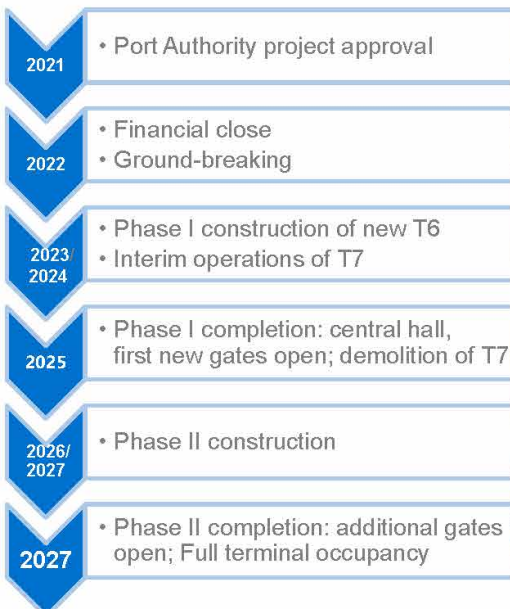

Mr. Price asked: Constructions material costs are up over the last 2 years. Copper, PVC, steel has risen by over 400% coupled by supply chain shortages that have put great financial strain on all construction related business. Will there be a price escalation clause or provision in the RFQs and/or contracts? If not addressed, it could potentially lead to MWBEs not being able to perform or meet their financial obligations.
