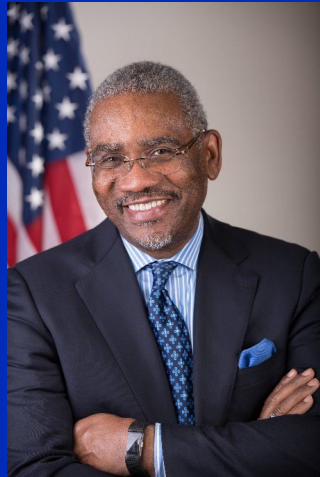

Remarks from our Community Advisory Council Co-Chairs

Borough President Donovan Richards

Shurn Anderson gave remarks on behalf of Borough President Donovan Richards who had a scheduling conflict. She thanked the Terminal Developers for all their work and congratulated Terminal 6 for their improved participation numbers.

Congressman Gregory Meeks

Congressman Meeks opened with congratulating Crescent Consultants and RF Wilkins for their great work tracking and managing the participation numbers as trusted community partners. They verify the participation numbers are real. He also acknowledged the new Interim CEO Steve Thody at Terminal 6 (and team) for their improved numbers since the last meeting. This puts them on track to meet their 30% MWBE goals.

Congressman Meeks also noted that the design and construction phase is starting to wind down (90% complete), thus the focus is shifting to concessions. Those who are ready will have great opportunities. Acknowledging access to capital, inflation, and high interest rates are barriers to success, he is working with local entities like Greater Jamaica Corporation on solutions

Congressman Meeks thanked Dr. Gerard Buschelle for his phenomenal work and welcomed the new CEO at The New Terminal One, Jennifer Aument. He is convinced she will maintain and increase the level community's access and involvement at The New Terminal One Dr. Buschelle started. He also announced the New Chief Engagement Office for the New Terminal One as one of our local community heroes, Melva Miller, who will add her talents to the success of the project.

The Community Advisory Council Committee members were reminded that their level of participation was being assessed. Those who no longer have the capacity to serve or haven't been responsive will be replaced. The work of the Community Advisory Council has produced success stories like over 700 attending the York College STEM Program , Council for Airport Opportunity partnership with RDRC and the Greater Jamaica Nexus to name a few.

Congressman Meeks ended with sharing that his colleagues in Government are impressed with the work of the Redevelopment and want learn about what we re doing in Southeast Queens as a model across the country. We are well on our way of eclipsing Atlanta as a benchmark for airport redevelopment success with community involvement.

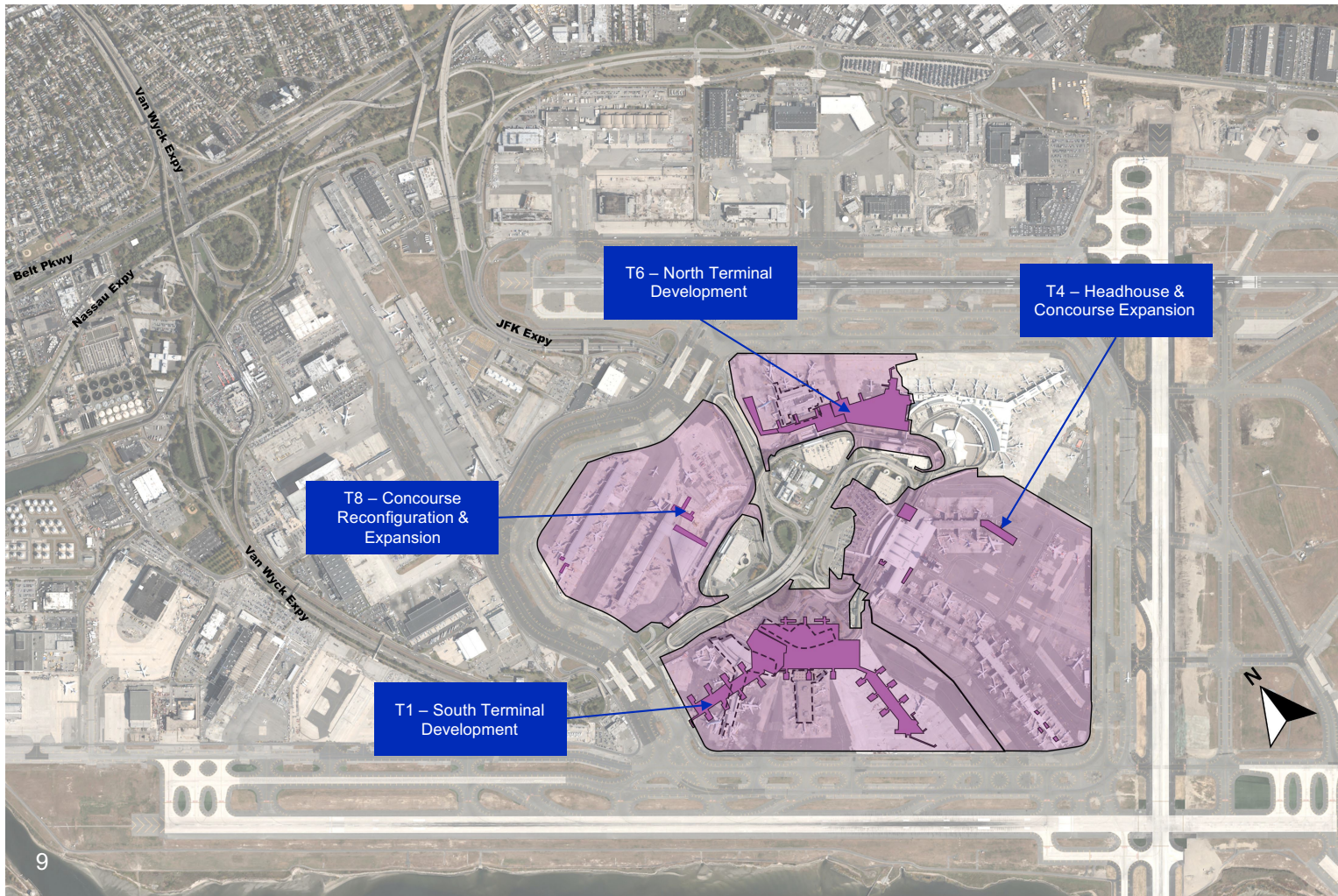

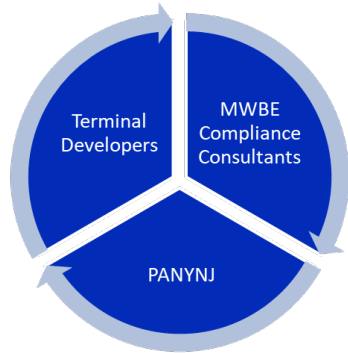

- ✓ Verify M/W/LBE contract awards (Affirmation Statements, Spot Checks, etc..) before input into the online reporting platform: ***B2GNow**
- ✓ Credit only for work performed by M/W/LBEs with their own workforce and equipment.
- ✓ Audits to check the accuracy of data inputted into the online reporting platform: **B2GNow**

Questions

Where are the minority women listed? What are the numbers of Minority Women?

Answer

The Port Authority's policy is to count ethnicity over gender. Minority women are counted under the minority category. The women category is only Caucasian women. All Minority women firms are included in the MWBE category. Every local Tier 1 or Tier 2 business is listed with their company name, MWBE status, the neighborhood they come from and if they have been awarded a contract. This information is listed monthly on our website (www.ANewJFK.com) by both the PANYNJ or Terminal Developers.

Additionally, consultants and all the Developers have consultant days at the JFK Redevelopment Office to assist with pre qualifications to increase these numbers.

Question

What is your percentage goal for Minority Women Business Enterprises and what is your percentage goal for Minority Women Workers?

Answer

The minority goal for businesses (which combines minority women and men) is 20%. It is 6.9% for skilled workers and 6.9% for laborers.

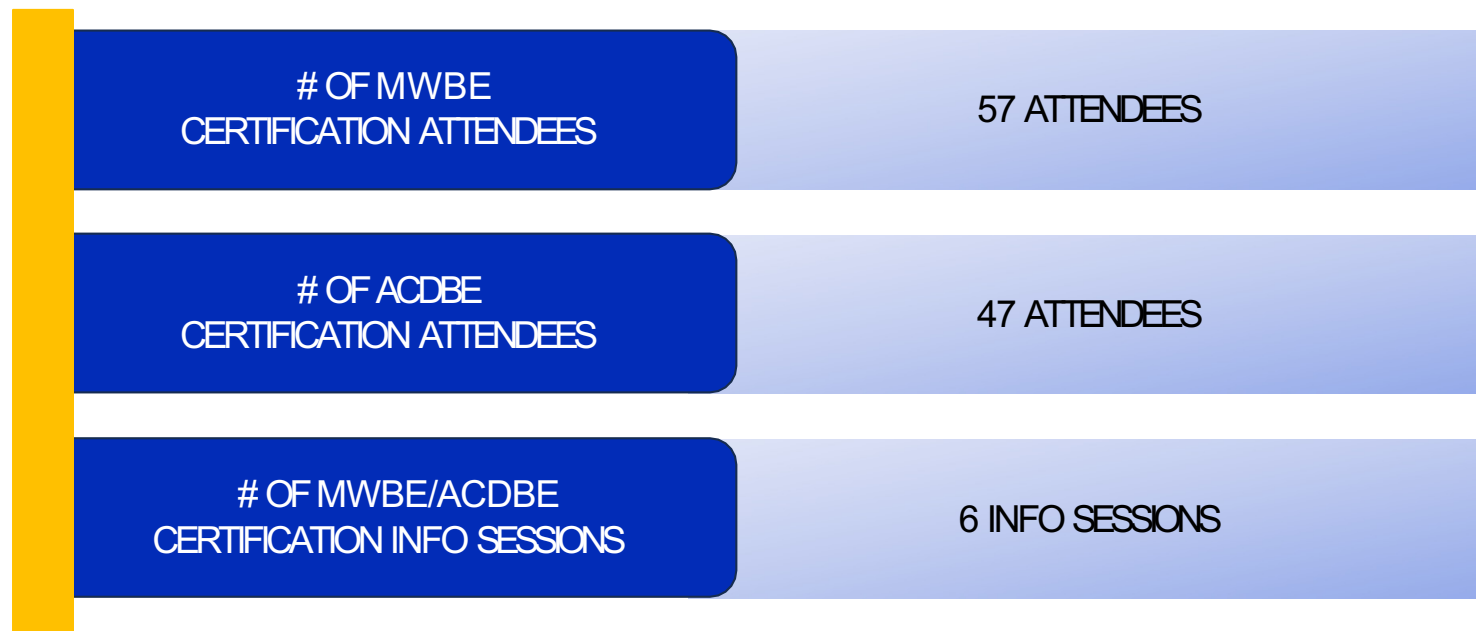

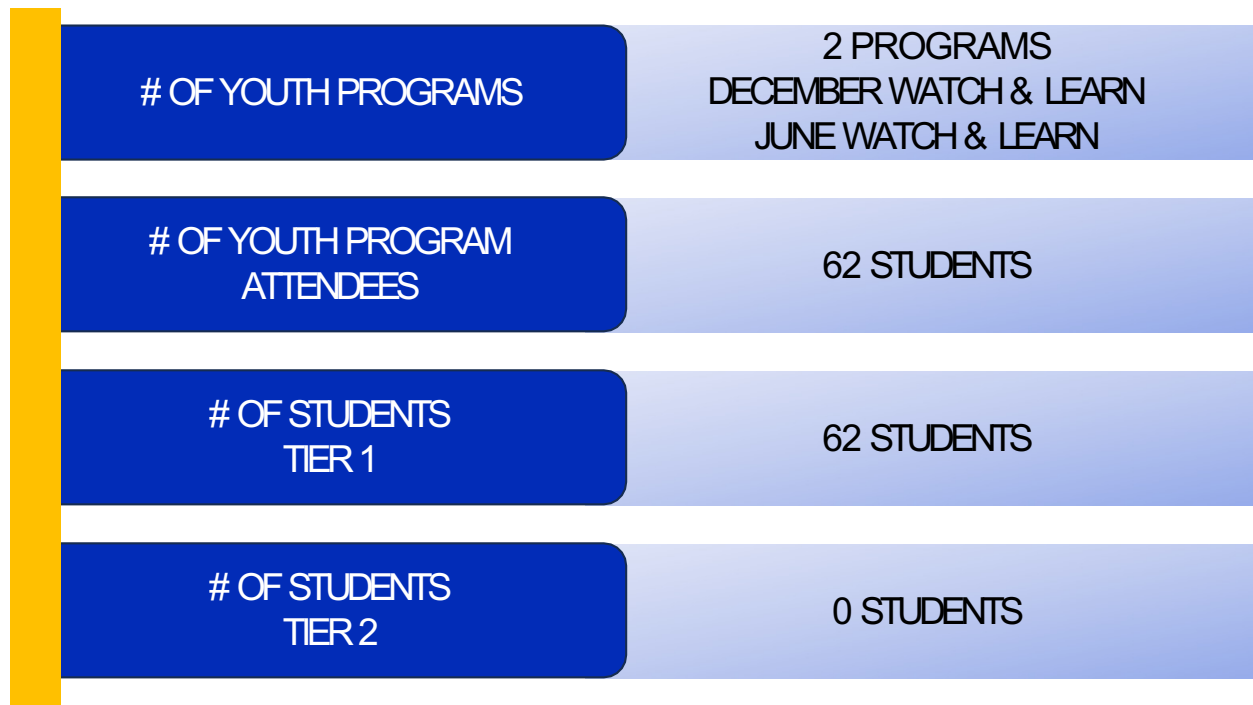

Comment

Councilwoman Selvena Brooks-Powers shared that recently City Council had a second Hearing on the JFK Redevelopment Program, and the Port Authority declined the invitation to attend. She is looking forward to make sure the JFKR Community Advisory Council Sub Committees are actively being engaged as no reports were given from the sub committees during today's meeting. Opportunity for community betterment will go through these committees so important that they meet. Additionally, it would be helpful to have a printed agenda for those in attendance to allow the community to participate in what is on the agenda so there is a level of input that the community controls and not just the Port Authority.

Question

When was the last time the sub committees met and what are the the frequency of the meetings?

Answers

The agenda for the Community Advisory Council meeting is posted on our website the day before the meeting. The PANYNJ has always shared that If any member of the community wants ask a question, make a suggestion, or would offer up an idea for the agenda they should always reach out to the Community Outreach Office and Community Outreach Managers. From the community feedback we received, we updated materials presented at these meetings, i.e. rather than just presenting quarterly data, we started posting monthly data on the website and remain open to other suggestions. We also work with Advisory Council Co-Chairs Congressman Meeks & BP Richardson to review the agenda and we increased the Q&A segments during the meeting today.

Sub Committees last met in 2023 and as Congressman Meeks mentioned, their participation and attendance is being evaluated. The Sub Committee Co-chairs also have the opportunity to reach out to schedule meetings

Question

In the beginning there was a 30% MWBE and now hearing 20% so asking for clarification.

Answer

It is very consistent with goals shared at the beginning of the project. The breakdown as follows: 20% for minority participation (MBE) and 10 % for women participation (WBE) for a combined 30%. These goals are informed by disparity study conducted by PANYNJ. The data from the study informed the percentages and matches the NY State goal.

Question

Are these legitimate women owned business?

Answer

Our PANYNJ certification specialist, Gloria Wigfall can confirm the rigorous screening process for these businesses and integrity monitors in place to protect the integrity of the data. The Minority category includes male and female.

30% goal applies not just to the cumulative project, but it applies to all four categories of the project; architecture & design, professional services, operations, and construction.

Question

Regarding the Solar Project, the local community will benefit with lower electricity bills – how will work in the local community ?

Answer

The solar program will run through the NYS Community Solar Program administered by NY Power Authority. They are focusing nearby lower income residences and for this project they are looking at nearby NYCHA developments for the benefits of the community solar project. More information will be shared as the project develops.
